2009 Giving in U.S.**

Charitable giving in the United States fell an estimated 3.6 percent to \$303.75 billion in 2009 from \$315.08 billion in 2008, or 3.2 percent when adjusted for a slight price deflation in the economy, a new report says.

In the face of the recession, the inflation-adjusted decline was less severe than the drop of 5.5 percent in the recession year of 1974, state Giving USA Foundation and its research partner, the Center on Philanthropy at Indiana University.

Charitable giving in 2008 fell 2 percent, or 5.7 percent after adjusting for inflation.

Reflecting a long-standing pattern, individuals gave the biggest share of donations by far, and religious groups received the biggest share.

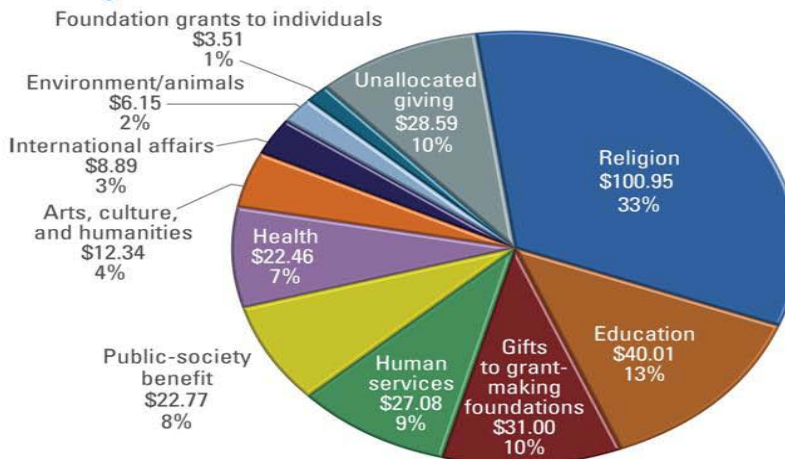
Giving to human services, health, international aid, environmental and animal-related groups all grew, while declines were posted in giving to education; religion; grant making foundations; arts, culture and humanities groups; and public-society benefit groups including freestanding donor-advised funds such as FJC.

Giving USA, which has reported on charitable giving in the United States since 1956, calculates estimated giving by over 75 million households, over one million companies, about 120,000 estates, and

roughly 77,000 foundations which goes to over 1.2 million charities registered with the IRS and to another 350,000 religious congregations.
